

## **Climbing Wall and Challenge Course Release, Indemnification Of All Claims, and Covenant Not to Sue**

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any injury to yourself or your property or for your death however caused arising out of your use of the Climbing Wall, now or any time in the future.

### **Acknowledgement of Risk**

I HEREBY ACKNOWLEDGE AND AGREE that the sport of rock climbing and the use of the Climbing Wall and Challenge Course (hereinafter referred to as the Climbing Wall/Course) has *inherent risks*. I have full knowledge of the nature and extent of all the risks associated with rock climbing and the use of the Climbing Wall/Course, including but not limited to:

1. All manner of injury resulting in falling off the Climbing Wall/Course and hitting rock faces and projections, whether permanently or temporarily in place, or the floor;
2. Rope abrasion, entanglement and other injuries resulting from activities on or near the Climbing Wall/Course such as, but not limited to, climbing, belaying, repelling, lowering on rope, rescue systems, and any other rope techniques;
3. Injuries resulting from falling climbers or dropping items, such as, but not limited to, ropes or climbing hardware;
4. Cuts and abrasions resulting from skin contact with the Climbing Wall/Course;
5. Failure of rope, slings, harnesses, climbing hardware, anchor points, or any part of the Climbing Wall/Course structure.

I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the Climbing Wall/Course and that the above list in no way limits the extent or reach of this release and covenant not to sue.

### **Release/Indemnification and Covenant Not to Sue**

undersigned user, agree to release and on behalf of myself, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE [YMCA], its officers, agents, and employees from any cause of action, claim, or demand of any nature whatsoever, including but not limited to a claim of NEGLIGENCE, which I, my heirs, representatives, executors, administrators and assigns may now have, or have in the future against [YMCA] on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to my use of the Climbing Wall/Course whether that use is supervised or unsupervised, however the injury or damage is caused, including, but not limited to the NEGLIGENCE of [YMCA], its officers, agents, and employees.

In consideration of my use of the Climbing Wall/Course, I, the undersigned user, agree to INDEMNIFY AND HOLD HARMLESS [YMCA], its officers, agents, and employees from any and all causes of action, claims, demands, losses, or costs of any nature whatever arising out of or in any way related to my use of the Climbing Wall/Course.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in the use of the Climbing Wall/Course and that I am voluntarily assuming the risks. I understand that I will be solely responsible for any loss or damage, including death, I sustain while using the Climbing Wall/Course and that by this agreement [YMCA] of any and all liability for such loss, damage, or death.

I further certify that I am in good health and that I have no physical limitations which would preclude my safe use of the Climbing Wall/Course.

**Contract to Follow Climbing Wall and Challenge Course Safety Policies**

I, \_\_\_\_\_ (**name of climber**) accept full responsibility for my own safety and the safety of other climbers while in the climbing gym and/or challenge course area. I agree to abide by, and to help enforce, the following Climbing Wall/Course Safety Policies:

1. No unbelayed climbing above the bouldering line.
2. Climbers must be roped and belayed through a belay plate. Belays must be anchored. Roped climbers and belayers must wear harnesses.
3. Climbers must wear helmets when top rope climbing (climbing above the bouldering line).
4. No lead climbing.
5. Inform other climbers of any situation seen as unsafe or not in accordance with the Climbing Wall Safety Policies. All climbers are asked to assist and encourage less experienced climbers.
6. All accidents or equipment damage must be reported immediately.

[YMCA] reserves the right to withdraw the membership of any individual permanently or for a specified period of time for breach of contract in following the Climbing Wall/Course Safety Policies, or for any conduct that is viewed as unsafe or inappropriate.
